
(Keith also serves as pastor at Cedar Shores). Thank you dear brothers and sisters! Your generosity knows no bounds!

Help Wanted!

Has God put it on your heart to serve Him in a new way in 2008? Please consider whether He would have you drive for Grace of Giving!

Here's what's involved:

- 5 days on the road getting a scenic view of God's wonders along the Texas/Mexico border;
- 7 deliveries in the Texas cities of Eagle Pass, Del Rio, Fabens, Van Horn, Presidio, and Terlingua;
- Unloading and loading a trailer several times (deliveries for a trip typically total between 13,000 and 14,000 pounds);
- Meeting and enjoying fellowship with devoted pastors and missionaries who serve in these areas of Texas.

Financial and Delivery Update

Through November, 2007, Grace of Giving has made 15 trips along the Texas/Mexico border to deliver food and personal items to our ministry partners. Here's a summary of what we've been privileged to do so far this year to honor our Lord and Savior:

- Total deliveries have exceeded 206,000 pounds, consisting of:
 - 153,400 pounds of bulk beans, rice, sugar, flour, and masa;
 - more than 20,000 cans of various food items;
 - 120 school supply kits;
 - 270+ cases of paper goods (primarily toilet paper); and
 - nearly 6,000 personal items (shampoo, toothpaste, etc.).
- The total cost of the delivered items is just over \$86,500.
- Contributions received in 2007 that were not designated for other purposes have been \$50,600.
- Thus, 59% of the cost of delivered items has been covered by outside con-

tributions. The remaining cost of delivered items and all other expenses have been funded from our personal savings.

Please join us in praying for God's wisdom and guidance as to how we should continue this ministry from a financial standpoint. There are several options that could be combined to decrease this personal financial burden as we move forward. We can (1) receive additional outside support, (2) find ways to cut our food purchase costs significantly, or (3) reduce our food purchases by decreasing the frequency of delivery trips (currently every 3 weeks).

We don't particularly want to consider option 3, but we must do so if options 1 and/or 2 don't come to fruition.

If you can help us meet the rising cost of acquiring food, we would be very grateful for your assistance. If you think of a way to help us cut the cost of acquiring high quality food, please let us know. Regardless, please join us in praying for God's guidance for Grace of Giving's ministry and share our needs with others in your church.
